No bids will be received or considered after the time of closing.

The Clackamas County Department of Transportation and Development is requesting bids to construct sidewalk improvements to SE 122nd Avenue and SE 132nd Avenue. The improvements include, but are not limited to excavation, storm drainage infrastructure, small retaining wall structures, paving, pervious concrete sidewalk, driveway connections and performing additional and incidental work as called by the specifications and plans.

This project is anticipate to take approximately 3 months and has two required completion time periods. The Contractor is required to complete all soil testing and material testing by February 28, 2017 and all work needs to be completed by June 2, 2017, except for seeding establishment work. The estimated construction cost range for this project is between \$500,000 and \$600,000 dollars.

This project includes Federal Funding.

To perform work, Bidders must be prequalified with Clackamas County in the class of Earthwork and Drainage (EART). **Under ORS 279C.430, proof of prequalification for the class of work herein must be submitted to the County by 2:00 PM, December 22, 2016. If the bidder is prequalified in the class of work with ODOT, they are rebuttably presumed qualified by Clackamas County.**

This is a public work contract subject to ORS 279C.800 to 279C.870 or if applicable the Federal Prevailing Rate of Wage required Under the Davis-Bacon Act (40 U.S.C. 3141 Et Seq.). All projects have minimum wage rate requirements. Each worker in each trade or occupation employed to perform work on the project shall be paid not less than the existing prevailing wage rate established by the Oregon Bureau of Labor and Industries (BOLI) or the applicable federal prevailing wage rate required under the Davis-Bacon Act, whichever is higher.

Clackamas County in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 200-4 and Title 49, Code of Federal regulations, Department of Transportation, subtitle A, Office of the Secretary, Part 21, nondiscrimination in federally assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color or national origin in consideration for award.

All federally funded projects have "BUY AMERICA" requirements. The project is subject to the DBE policy statement as cited in 49 CFR 26. The DBE Goal for this project is 0%. The Reimbursable On-the-job Training requirement is 0 hours.
