ADDENDUM NUMBER 3  
December 27, 2017

On November 21, 2017, Clackamas County Services District No. 1 (“CCSD#1”) and Water Environment Services (“WES”) (collectively “WES”) published Request for Proposals #2017-77 (“RFP”) and on November 29, 2017 published Addendum #1 and on December 20, 2017 issued Addendum #2. WES has found that it is in its interest to amend the RFP through the issuance of this Addendum #3. Except as expressly amended below, all other terms and conditions of the original RFP and subsequent Addenda shall remain unchanged.

1. SECTION 3 – SCOPE OF WORK

3.2. SCOPE OF WORK

**Add the following to 3.2.1. Scope:**

**A. SCOPE OF WORK: DIGESTER CLEANING  
SAMPLE REQUEST**

Proposer may request a sample of the digester material for testing and analytical purposes. Testing for analytical data may help proposer decide best course of action for landfill disposal. Testing samples will consist of a maximum of two (2), five (5) gallon buckets of digester material. The cost for all testing will be the sole responsibility of the proposer and WES will in no way offer reimbursement for any testing.

Fee proposal to include:

- All inclusive – covers all direct and indirect necessary expenses
- Not-to-Exceed – the Cost per dry ton shall not exceed the amount specified on each line of the fee proposal.

- A. **Digester Cleaning:** Cost per dry ton for removal and disposal of 90,000 – 250,000 gallons of digester liquid (Kellogg and Tri-City, per cleaning)

- B. **On Call Biosolids Removal / Disposal:** Cost per dry ton for removal and disposal of 250,000 – 500,000 gallons of digester liquid (Kellogg and Tri-City, per cleaning)

- C. **Solids Removal:** Cost per cubic yard for removing and disposal at a State licensed landfill of approximately three (3) to eight (8) cubic yards of rags and other debris from digesters (Kellogg, Tri-City and Hoodland, per removal/cleaning)
