

**Septic & Onsite Wastewater Systems
2016-2017 Fee Schedule**

Effective May 9, 2016

To offset a portion of the Oregon DEQ administrative program oversight costs of the statewide onsite wastewater management program, the DEQ and contract counties must levy a surcharge for each site evaluation, report permit, and other activity for which an application is required. This surcharge does not apply to sewage disposal service license applications, pumper truck inspections, annual report evaluation fees, or certification of installers or maintenance providers.

Each county having an agreement with the Oregon DEQ under ORS 454.725 must adopt a fee schedule for services rendered and permits issued. The County Fee Schedule may not include the Oregon DEQ surcharge established in Section 9 of the On-site Wastewater Disposal Rules unless identified as an Oregon DEQ surcharge.

Proceeds from surcharges collected by the DEQ and contract counties must be accounted for separately. Each contract county must forward the proceeds to the DEQ in accordance with its agreement with DEQ.
